Judah's husband was Drury Watts and they lived next to a younger Moses Pruett in 1810 in Warren Co, KY. (Allen was formed from Warren Co in 1815) Judah was born in SC. David Pruett lived in Pendleton District in 1790 next to his son Drury. There were Watts in Pendleton at the time.

Drury and Judah/Judith were not all that common of names but both were used in the Pruett/Prewitt family. I wonder if the connection between these families isn't deeper?
