In the absence of any documentation, I am appreciative of Richard's work. Of course I can't prove what I use but then others can't prove what they say about the family either because there are no records!

I have two of Richard's books, "Prewitt-Pruitt Records of Virginia" (Revised 1993) and "Samuel Pruitt I and Elizabeth Hawker, Their Descendants" (1997). They have been invaluable to me as starting points for my own research. The "Records" book is supposed to be a recitation of records that Richard found in various courthouses throughout Virginia and some counties in Maryland. Interspersed throughout this volume, however, are "facts" that may or may not stand up to scrutiny. For example, under Pittsylvania Co., Va., 1809, March 16, Richard recites a marriage record for Asa Prewitt, my ggggrandfather. He then goes on to state that Asa was the son of John Prewitt, Jr. without giving a source for that information and without making it clear that this is his opinion, not necessarily fact. I believe Richard is correct in this opinion, but I have not found a record that would substantiate it. In a section on Frederick Co., Md., Richard gives a synopsis of the will of Samuel Pruitt I which has some errors. For example, he says that his son Samuel was to get Henry Dollin for the remainder of his servitude, when in fact the will states that his wife got Henry; the son would only get Henry if Elizabeth died before Henry turned 31. Later in that section Richard says that Samuel Pruitt I bought a piece of property called Easy Purchase on Nov. 22, 1737 and then renamed it Pruitt's Purchase. In fact, a Sept. 22, 1737 document clearly states that Samuel was signing a lease agreement for 100 acres of the 900 acre property known as Easy Purchase. Easy Purchase definitely remained in the hands of the Beale family and was later sold by them to others. The Samuel Pruitt/Eliz abeth Hawker book perpetuates these two errors and others. The book seems to be a compilation of information from other Pruitt researchers and a lot of the information is not sourced. Having said all this, I can only repeat that Richard's books are excellent compilations of information from county and family records and are very good starting points for our own research. However, I would not, generally, cite Richard's books as the source of my information. We should go to the original source material to verify that it was accurately transcribed or synopsized.

Mardine...I just ran across this and I have no idea if it's meaningful or if you have already researched it, but here goes:

From a publication entitled: "Marylanders to Caroina".. Migration of Marylanders to North Carolina: William Hopkins was born in 1762 in Fredericks County MD and lived in what became known as the Shendoah Valley in VA at the time of his enistment in the Rev. War. He lived there for some time and then moved to Chatham Co. NC. In 1810 he moved to Union Co. SC for a short time and then to Wilson Co. TN.for 2 y ears. He then moved to Adair Co. KY for a few months and then to Wayne Co. KY before returning to Adair. On January 7 1834 he applied for a pension. SOLOMON PREWITT SR. OF CUMBERLAND CO KY AGE 86 WAS A "NEAR RELATIVE". (Ref VDW-1709)

I would like to add my 2 cents worth. I find that the accumulation of data from whatever source is important in developing the picture we are trying to paint. Unless we have the original source and conclusive proof we cannot be totally sure about any of it. So accumulate your data and keep it handy for confirmation or rejection as it will prove of use giving us the direction we need to go to get to our final destination. I have over 25000 names in my database and periodically do a matching exercise to determine if there are duplicates and even with that I have not been able to create a paper trail to arrive at my ancestors. Only by DNA have I been able to establish the place I need to go, now its finding a way to get there. All data helps, either for elimination or confirmation. Richard Prewitt's work is of a great deal of use to help with that effort. I really appreciate the amount of work that has gone into his publications.

Sallie Stancil & had chn-William McCarty Hopkins, Mark Hopkins, Moses Hopkins, Levi Hopkins, Solomon Hopkins, Sally Hopkins, & Mary (Polly)Hopkins.(Probably the writer, Mr. James T. Hopkins, Bryan, Texas, hoped to claim part of Mark Hopkins estate in CA)
